- NEW 2019 IRS Health Savings Account (HSA) Maximums Now is a great time to think about starting or increasing your HSA contributions for 2019. Take advantage of the increased annual maximums of \$3,500 for individual and \$7,000 for family coverage AND the triple tax-breaks of HSA's:
  - 1. tax-deductible contributions / or pre-tax if made through payroll deduction
  - 2. withdrawals for qualified expenses (for self and dependents) are tax-free
  - 3. savings grows tax-free.
